

FAMILY AGREEMENT FOR STUDENTS PREVIOUSLY SHIELDING.

Following the updated guidance from the government on Wednesday 4th November 2020, Greenvale School has created this agreement for families of young people previously shielding who wish for their son/daughter to continue to access school during the national lock down. Families are asked to review the guidance outlined below and to review our updated risk assessments (available on our website) before making an informed decision on this matter.

National Guidance

Government guidance released on Wednesday 4th November offers advice to the 'Extremely Clinically Vulnerable' category and should therefore remain at home during the national lock down.

Minister Ford's letter to the SEND sector 9th Nov

"The DHSC guidance for clinically extremely vulnerable children is not compulsory, although parents are strongly advised to follow the guidance in order to keep their child safe. However, in some exceptional circumstances parents whose children are clinically extremely vulnerable may need to balance the health risk with the wider implications associated with the child or young person not attending their usual education setting and accessing the support that would normally be delivered through this placement. This may be based on the level of support that a child or young person needs, their ability to access remote education and additional services such as therapies, and the impact on wellbeing for the wider family



of their child being at home full time. In these circumstances, parents, education settings, health professionals and local authorities should work together to agree the best arrangement for that individual child or young person and their family to ensure that they continue to receive the support they need."
